# PERSONAL INFORMATION WE COLLECT:

"Personal Information" is defined as information that can be used to identify you and may include details such as your name, age, gender, contact information and details, incoming/outgoing messages, business information, products and services you are interested in or require more information about. Insofar as sensitive personal information is concerned, it will carry the meaning as may be defined by applicable laws from time to time.

We collect, use, share and retain your personal information in the following manner:

# Collection

# **Collection:**

# **Usage:**
